TERMS & CONDITIONS

1 WHAT SELECTED HOSTED BUYERS EXPERIENCE

Selected Hosted Buyers are welcomed as priority guests of the International Apparel & Textile Fair and are offered a structured, well-supported environment designed to maximise access, relevance, and business efficiency.

As part of the Hosted Buyers Program, selected participants may experience:

- Curated access to a diverse and international exhibitor base aligned with their sourcing objectives
- A guided meeting environment designed to optimise time on the show floor
- Hosted Buyer recognition and priority positioning during the fair
- Dedicated on-ground support from the organiser's buyer relations team
- Access to networking opportunities designed to facilitate high-quality business discussions
- Organiser-supported hospitality during the official program dates
- Eligibility for airfare support as a facilitative incentive, subject to program terms

The Hosted Buyers Program is designed to feel personal, purposeful, and premium, while maintaining a strong focus on genuine business engagement.

2 AN EXCLUSIVE INVITATION FOR YOU

You are being considered for the Hosted Buyers Program because your profile, buying influence, and sourcing relevance are recognised as valuable to the success of the International Apparel & Textile Fair. Hosted Buyers are not general visitors, but carefully selected industry decision-makers whose presence plays a pivotal role in shaping the quality, outcomes, and global standing of the fair. The program is designed to welcome you as a priority guest, offering a curated experience built around access, relevance, and meaningful business engagement. With this level of recognition comes a shared commitment to uphold the standards and intent of the Hosted Buyers Program.

3 SELECTION AND PARTICIPATION PHILOSOPHY

The Hosted Buyers Program is selective by design. It is intended for buyers with genuine sourcing intent, professional engagement standards, and the ability to contribute meaningfully to the exhibitor ecosystem.

Participation in the Hosted Buyers Program, including hosted benefits, recognition, and organiser-supported hospitality, is contingent upon meeting the participation expectations outlined below.

4 PARTICIPATION EXPECTATIONS

As a condition of participation in the Hosted Buyers Program, all selected buyers, irrespective of whether airfare support is claimed, confirm and agree to the following:

- Full attendance at the International Apparel & Textile Fair on 18 May from 10:00 AM to 6:00 PM and 19 May from 10:00 AM to 6:00 PM

Participation in a minimum of 15 meaningful, business-oriented meetings per day, specifically:

- are expected to be purposeful, professional, and commercially relevant, with a focus on creating genuine value for exhibitors.
- 15 meetings on 18 May, 2026
- 15 meetings on 19 May, 2026
- Buyers are free to select and manage their own meetings based on their sourcing priorities and business interests. No fixed meeting agenda or meeting duration is imposed, recognising that some discussions may be brief while others require more in-depth engagement.
- Where the organiser identifies strong business alignment between a buyer and specific exhibitors, the organiser may request the buyer to meet a limited number of pre-selected exhibitors. Buyers commit to honouring such requests as part of their participation in this curated program.

The organiser may assess participation based on meeting records, exhibitor feedback, and on-ground verification. Failure to meet participation expectations may result in withdrawal of Hosted Buyers Program benefits.



5 FULL ATTENDANCE REQUIREMENT

Hotel Check-in & Check-out: Check-in on May 17th, 2026, from 3:00 PM onwards, and check-out on May 19th, 2026, after breakfast before heading to the fair. Luggage storage will be available at the hotel's concierge.

The Hosted Buyers Program is intentionally structured across both official fair days to allow meetings to unfold naturally, support relationship building, and ensure a consistent Hosted Buyer presence on the show floor.

Buyers who are unable to commit to full attendance during the official program hours on both days are respectfully requested not to apply for the Hosted Buyers Program and may instead consider visiting the fair independently.

Where the organiser hosts an official gala dinner or hosted networking evening during the fair, Hosted Buyers are requested to participate as part of the curated program experience.

6 HOSTED BUYER VISIBILITY AND PROMOTION

As part of the Hosted Buyers Program, selected buyers are featured as priority guests of the International Apparel & Textile Fair.

To support program visibility and celebrate buyer participation, selected Hosted Buyers agree to provide, prior to their arrival in Dubai, a professional photograph, company logo, and a short written testimonial outlining their expectations and interest in the fair. This enables the organiser to promote their participation and build anticipation around their VIP presence ahead of the event.

In addition, Hosted Buyers agree to share a brief on-ground video testimonial during the fair reflecting on their experience and engagement. These contributions play an important role in showcasing the quality and credibility of the Hosted Buyers Program globally.

7 TRAVEL AND ACCOMMODATION ARRANGEMENTS

To ensure smooth planning and personalised arrangements, organiser-supported hospitality such as hotel accommodation and meals are confirmed after the buyer has shared their confirmed travel booking, allowing arrangements to be aligned with committed travel schedules.

Where hotel accommodation is provided, it is limited strictly to a standard single-occupancy room for the official program dates only. Any additional nights, room upgrades, double occupancy requests, room service, minibar charges, incidental expenses, or other extras must be arranged and paid directly by the buyer with the hotel. The organiser will not liaise with the hotel regarding such changes.

Visa & Travel Assistance

- You may apply for your Dubai visa through our official travel partner, who can also help you verify if you're eligible for visa-free entry or visa on arrival.
- We recommend getting in touch with them directly for the most accurate and up-to-date guidance. For any additional queries, our team is always here to assist you.

Airport transfers are not provided as part of the Hosted Buyers Program.

AIRFARE SUPPORT

As part of the Hosted Buyers Program, selected buyers may be considered for airfare support of up to USD 150 or a one-way economy airfare, whichever is lower, subject to compliance with the program framework.

Airfare support is extended as a facilitative gesture to support buyer participation and is not the primary purpose of the Hosted Buyers Program.

Important Terms Related to Airfare Support

Airfare support, where approved, is provided in cash and may be collected only during the designated collection window:

- Date: 19 May 2026
- Time: 5:00 PM to 8:00 PM
- Location: Organiser's office, outside Hall 4, Dubai World Trade Center

All airfare invoices submitted for consideration must:

- Be issued strictly in United States Dollars (USD)
- Be issued in the buyer's registered company name
- Relate exclusively to travel between the buyer's country of origin and Dubai (tickets involving onward journeys, multi-city routes, or combined travel sectors are not accepted)

All required documentation must be submitted and pre-approved prior to arrival in Dubai. Submission of documents does not guarantee airfare support, and approval remains at the organiser's discretion.

7 COMPANY AUTHORISATION (NO OBJECTION CERTIFICATE)

For verification purposes, buyers may be requested to provide supporting company documentation such as annual import volumes, trade license details, and tax registration certificates.

Submission of a valid company-issued No Objection Certificate (NOC) is mandatory for participation in the Hosted Buyers Program.

The organiser will provide a prescribed NOC format, and the NOC must be submitted strictly in this format only.

The NOC must confirm that the nominated buyer is authorised to represent the company at the International Apparel & Textile Fair, participate in the Hosted Buyers Program, and collect airfare support, if applicable, on behalf of the company.

The NOC must further acknowledge responsibility for costs incurred in the event of non-attendance, with provision for an alternative representative where applicable.

8 PROGRAM EXCLUSIONS:

- **Meals taken outside of the scheduled program activities** are not included and will not be reimbursed by the organizers.
- **Hotel extras:** Mini-bar, room service, upgrades, and personal expenses – Buyers will be responsible for any damage caused to hotel property during their stay. Any such charges must be settled directly with the hotel upon check-out.
- **Unspecified transport:** Any transportation not mentioned in the invitation.
- **Visa & travel insurance:** Buyers are responsible for their visa and insurance.
